In addition overheads max. 24 % are eligible.
Calls	Calls are not published by the Managing Authority. Cooperation can be integrated in the LDSs and implemented as part of these.
Project selection	The local action group selects projects for preparatory actions, inter- territorial and transnational cooperation.
Budget allocation for cooperation to LAGs	Based on the relevant LDS
