Situation at the end of 2016


This factsheet contains monitoring data aggregated at EU level (EU-28), providing a comprehensive overview of the state of play in the implementation of the rural development Priority 3 (P3) 'Promote food chain organisation, including processing and marketing of agricultural products, animal welfare and risk management in agriculture'. In particular, Section 1 presents financial expenditure¹ aggregated at EU level and broken down by Member State (MS), covering the period between 2014 and end 2016. 
1. Financial expenditure (RD Priority 3)


Table 1: Overview of financial expenditure for P3 at EU level (EU-28) - Billion EUR.
