

# RDPs 2014-2020: Monitoring data Rural Development Priority 2 (P2): Enhance farm viability and

competitiveness and the sustainable management of forests Situation at the end of 2020


This factsheet contains monitoring data aggregated at EU level (EU-28), providing a comprehensive overview of the state of play in the implementation of the rural development Priority 2 (P2) 'Enhance farm viability and competitiveness and the sustainable management of forests'. In particular, Section 1 presents financial expenditure<sup>1</sup> aggregated at EU level and broken down by Member State (MS), covering the period between 2014 and end 2020. Section 2 presents the progress realised towards the EU common target indicators linked to P2.

## 1. Financial expenditure (RD Priority 2)


This section presents information on the progress made on public financial expenditure until December 2020, aggregated at EU level (EU-28) and broken down by Member State. The information includes planned, committed and realised expenditures, and the progress made towards achieving the planned public expenditures under P2.

Table 1: Overview of financial expenditure for P2 at EU level (EU-28) - Billion EUR.




Map 1: Member States with progress towards their P2 planned public expenditures above the EU average of 52% (based on realised expenditure).

In this factsheet, public expenditure means total public expenditure (= EAFRD + Member States matching funds + any national top-ups). Due to rounding, there may be small discrepancies between some figures presented. Data illustrated cover the programme implementation period between 2014-2020.
