
M16 in Finland

- 1 Rural development programme in Mainland Finland,
 15 Regional rural development plans and 54 Local rural development strategies (Leader)
- State Aid rules (EIP: ABER art. 31 and other submeasures: GBER art. 25)
- de minimis for entrepreneurs co-operation group: small scale co-operation between 3-10 entrepreneurs working with rural businesses. Suitable development association/organisation as a project manager / coordinator.

Possibilities under the co-operation measure

- Development project for economic activities with a clear focus
- No planning of planning! Driven by need! Research results to practice!



- 4. demonstrating cooperation, partnership and commitment (20%)

Rural innovation project (selection committee)

According the plan, the potential of the project:

- 1. to enhance the strategy of the program, its targets, solving problems (25 %)
- 2. to generate new business (25%)
- 3. to meet the needs, use best partnership and commitment (25%)
- 4. to present quality, cost effectiveness and feasibility (25 %)


